1. **Incorporates the latest edition of the** *"Case Law of the Boards of Appeal of the European Patent Office"* edited by the Legal Research Service of the Boards of Appeal of the EPO (DG 3) offering an overview of the case law of the Boards of Appeal to the end of December 2001 in the three official languages (English, French, German).
2. **For users of the European Patent Convention (EPC)**, in particular, attorneys-at-law, qualified representatives, candidates for the European Qualified Examination for Professional Representatives, as well as, patent examiners. This CD-ROM may be used to locate decisions of the Boards of Appeal relevant to a current case easily and expeditiously.
3. **The work is structured as follows:** dividing the case law into topics, then illustrating each by short summaries of selected decisions. Many chapters have been thoroughly revised, to give a full picture of the actual case law.
4. Available for the first time on CD-ROM in HTML format (Hyper Text Markup Language) and in the PDF format (Portable Document Format). It **offers full search facilities** by using a Java based search engine included on the disk. The search feature either allows searches on the whole contents of the disk or parts of it. The HTML files require the use of a standard Internet browser.
5. **The CD-ROM also includes:**
  - The **full text of most decisions of the EPO Boards of Appeal** and Enlarged Board of Appeal, cited in the *"Case Law of the Boards of Appeal of the EPO"*. Most published decisions of the EPO Boards of Appeal are available in the three official languages of the EPO, the unpublished ones are available in the language of the proceedings.
  - **Index of published decisions of the Enlarged Board of Appeal** available in the three official languages of the EPO.
  - The text of the **European Patent Convention (EPC)**.
  - The text of the **Patent Cooperation Treaty (PCT)**.
  - The **"Ancillary Regulations to the EPC August 2001"** which includes i.e. the Regulation on the European qualifying examination for professional representatives, Regulation on discipline for professional representatives, Rules of Procedure of the Boards of Appeal.
